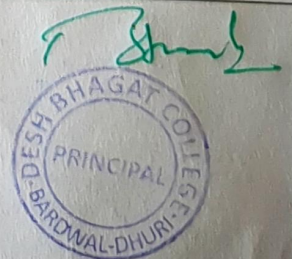
### How to Apply under RTI Act
