The aforesaid Reservation Policy has been reviewed and it has been depicted to retain the previous policy in terms of substantive percentages of reservation for the vanous categories. The percentage of reservation for each of the categories shall be as under-

(If suitable candidates are not available in anyone of these sub-categories the seats so available will be filled up by the candidates from the other sub-categories of disabled candidates and if they are not available in any sub-category then seats shall be filled up from general category candidates.)

be treated as a part and parcel of this communication Nothing in the aforesaid policy shall apply to the courses run by the three unwersities in the state other than Punjab Tochnical University Jalandhar in respect of the courses offered by them in their campuses or their regional centres. Admission to theke courses shall be governed by the reservation policy trained by the respective University
