# **<u>1. EXECUTIVE SUMMARY</u>**

# **1.1 INTRODUCTION**

Desh Bhgat College, Bardwal-Dhuri is one of the leading institutions of the Punjab being run by Desh Bhagat College Bardwal Trust. The institution started with the blessings of Sant Baba Ranjit Singh Ji Mullowal in 1982. The college is affiliated to Punjabi University, Patiala and is listed under 12(b) & 2(f) sections of UGC Act 1956. The college was established to make education accessible to and affordable by the people of all categories. At present, the College is accredited with 'B' Grade by the NAAC (National Assessment and Accreditation Council). The college is running 07 PG, 12 UG and 01 PG diploma courses. This multifaceted coeducational post graduate college fulfils the educational needs of about fifty villages around Dhuri, Sangrur and Malerkotla in a radius of more than 40 kms. At present, this college stands at its apex by virtue of being one of the greatest institutes and has become the nucleus of academic centre in Humanities, Commerce, Management, Science and Computer Science. This college offers B.A., B.Com. (Regular), B. Com. (Hons.), B.A. B.Ed Integrated course, B.Voc (Software Development), B.Voc (Retail Management and IT), B.B.A., B.C.A., B.Sc.(Non Medical), B. Sc.(FT) and B.Sc. (MCM) at undergraduate level. The college also offers post graduate courses such as M. A. (English), M. A. (Punjabi), M.A. (History), M. Sc (IT), M. Sc. (IT) LE, M.Sc (Maths), M. Com and P.G.D.C.A. # **Curricular Aspects**

The institution has developed a structured and effective implementation of the curriculum- its planning and delivery, through systematic and strategic transparent mechanism. College enables the students to choose and join the program as per their eligibility. Within this predetermined academic setup, College ensures effective delivery of course curricula for benefit of its students of all streams. The Time Table is prepared by the Committee headed by senior faculty member. Library of our college is well stocked 17316 books, reference books, journals and magazines. E-resources are available through INFLIBNET, eLib-syspro to enhance their subject knowledge. Punjabi University Patiala has opened Library Distance Center in this College for those students who are taking education from correspondence Course, Punjabi University Patiala and students are free to take books from this Library .Laser Printer cum Scanner and Photocopies are also available. Library also provides training /apprenticeship to the students of Library and information Science. Books and Magazines on competition, current affairs, and general personality development are also available as a measure to improve curriculum planning and implementation, faculty members actively attend and participate in FDP and workshops. Interactive platforms such as YouTube, google meet, zoom were used during COVID Pandemic for effective teaching. Desh Bhagat College iniatiated its own YouTube channel where co-curricular and extracurricular activities are uploaded. 41 Add-on and certified courses are offered to the students to enhance livelihood skills, aptitude and to empower the students for self-employment. The courses designed has integrated cross cutting issues relevant to professional ethics, gender, human values, environment, and sustainability in the curriculum with a view to ensure holistic development of the student. Undergraduate students of all streams have to opt for Punjabi or Mudla Gyan which imbibes cultural and religious values among the students; and have to also opt for Environment and Road Safety and Drug Abuse to qualify for the completion of course. Outreach activities, blood donation camps, tree plantation and Swachhata campaigns help in the development of civic and social responsibilities among students. The Institute obtains feedback from stakeholders and analyzes them to identify corrective actions required for the improvement.

Programme and course outcomes, along with syllabi, are accessible on Punjabi University's website and in college library. Slow learners receive remedial classes, assignments, and tutorials to improve their skills, while advanced learners are encouraged to pursue additional value added coursesfor career advancement. # Institutional preparedness for NEP

1. Multidisciplinary/interdisciplinary:	Desh Bhagat College, Bardwal has a few interdisciplinary and multidisciplinary programmes, in order to give the exposure of different fields to the students. These interdisciplinary courses provide opportunities to the students to groom their skills in fields other than their main discipline. Rather than limiting students to one particular discipline these courses widen their horizon as they complement each other. They also support new ideas to help the students. Students learn new things along with their main field. The flexibility in our education system to
	choose interdisciplinary and multidisciplinary programmes as per their interest helps students to compete at global level. Mathematics and Computers

	can be opted by science as well as arts students. Moreover, it also offers them opportunities and avenues to learn their core subjects and also helps them to explore additional avenues of learning beyond the core subjects. As far as co-curricular activities are concerned, there is no department wise segregation in conducting the activities.
2. Academic bank of credits (ABC):	As per the requirement of University Grants Commission there is a need to establish and operate Academic Bank of Credits in Higher Education Institutions. The institution has planned to register all the students to the Digilocker facility and get them registered in the Academic Bank of Credits. The college is preparing itself in the above matter. The college is running course under CBCS Scheme.
3. Skill development:	Our institution provides vocational and skill training programs which serve to transmit knowledge and skills to students. The college is running skill development courses for B. Voc. (Software Development) and B. Voc. (Retail Management and Information Technology). These courses emphasize on the development of employment skills and entrepreneurship among the students. Moreover, communication, organization, teamwork, timeliness, critical thinking, creativity, adaptability and computer literacy skills are taught to students through these courses. Teachers assist students in becoming productive workers by teaching them the value of working in teams. The importance of perseverance is emphasized in these seminars. Students design their futures throughout these sessions. Students learn entrepreneurship skills in these courses. Additionally, the college provides U.G. courses that improve skills. Our labs provide hands-on learning opportunities where instructors instruct students. Undergraduate Fashion Technology students also acquire the skills required to launch their own businesses. They also pick up skills like stitching, embroidery, pattern design, and other things required in the fashion industry.
4. Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course):	The Indian Knowledge System comprising Indian language and culture being an integral part of our life needs to be taught to the students. The institute is preparing itself to impart Indian knowledge as it is planning to make students acquainted with the healthy lifestyle prescribed in Ayurveda. The institute

	is making an effort to incorporate expert lectures in the offline as well as in online form. The Ayurveda expert will enlighten students regarding the diet and exercises related to healthy lifestyle. They'll be inspired to steer clear of junk food as much as possible. In a similar vein, the students will gain extensive knowledge of yoga from yoga specialists. The Native Indian through both offline and online yoga classes, they will learn a method of physical and mental fitness. Students are taught the value of their mother tongue, Punjabi, by commemorating "Maat Bhasha Diwas" (mother tongue day), and the national language, Hindi, by celebrating Hindi Diwas.
5. Focus on Outcome based education (OBE):	By posting program outcomes, program-specific outcomes, and course outcomes on the college website, the institution focuses on the results of a program. The program's results assist in determining the benefits of the particular program. The students find it easy to select and apply to the programs that interest them. They can undoubtedly conclude what are they going to learn in the particular program, how the program will hone their abilities and in which area they can get their employment. The program results give more extensive perspective on the program to the students. The understudies can break down and assess the results by going through the program results. Course outcomes describe the outcomes of specific paper. The students can judge what they are going to learn in specific paper. They can analyse how the knowledge acquired by each paper is going to help them in their career. They also know how their practical skills are enhanced in a particular practical paper. Moreover, they learn how theoretical knowledge acquired by them can be applied practically. the students come to know about the pros and cons of the programme so that they can decide about their career easily.
6. Distance education/online education:	Desh Bhagat College has successfully connected with its students during the Covid-19 pandemic. Teachers made the most of technology while students were confined to their homes during the lock down. Teachers are exploring different online platforms like Google Meet and Zoom to teach students. Constant communication with students helped maintain the necessary relationship between teacher and student. Teachers became students and learned to plan Zoom and Google Meet lessons. They made additional

email addresses for assignments, MST exams and university exams. Although the traditional direct learning method in classrooms cannot be replaced at any cost, but with the help of digital teaching and learning the pandemic has been overcome. Teachers taught and learned interactively virtually. The university found many ways to reach more students and offered them various classes. Lessons, assignments and exams were given online. Online classes have been beneficial for all students. The pandemic could not stop our activities, although it limited them. It made us stronger and better prepared
to face such challenges.

## **Response:**

The institution is affiliated to Punjabi University, Patiala, so it adopts the curriculum overview provided by the university. The college has developed a structured mechanism for effective adoption, curriculum delivery and documentation. Our faculty as members of Board of Studies of Punjabi University substantially contributes to the curriculum development. The operationalization and execution of curriculum implementation process is set with an overall frame work. It begins with the pre-semester planning to achieve the institutional goals. The Time Tables are displayed on the Notice Board and shared in WhatsApp groups. The syllabus link of university is also provided to the students. To materialize this process, Academic Calendar is formulated by the IQAC. There is a plethora of student enrichment activities e.g. seminars, workshops, webinars, expert lectures, industrial trainings, special talks etc. along with outreach activities like field tours, educational excursions etc. which helps the institute to achieve the values being emphasized and focused. Post semester activities including collection and documentation of student feedback and submission of internal assessment are performed. The following strategies are followed to ensure the effective curriculum planning and implementation:

At the beginning of the Academic Session, Institution IQAC, HOD's and Academic Council prepare the Time table and Academic Calendar in coordination with Affiliating University academic calendar for smooth conduct of the session.

All the departments hold meetings before the commencement of session to plan for the effective implementation of the curriculum as per Academic calendar. Further, systematic allotment of the subjects is done by the HOD's as per the Time Table through discussions in departmental meetings.

Course files have been made mandatory for the faculty and are periodically checked by the HODs to see the linkage and mapping between the program objectives and outcomes. Periodic review meetings are conducted by the HODs to discuss the coverage of the syllabus and solutions to the lacunae if any.

The college has enough infrastructure to meet the current requirements. Many of the class rooms are ICT facilitated and labs are well-equipped with necessary equipments and apparatus to meet the requirements of the curriculum.

The college library is well-stocked with necessary relevant print and electronic resources including text books, reference books and scholarly journals, catering to the different requirements of the students and teachers.

Regular class tests, internal examinations, assignments, seminars etc. are held for the internal assessment

of the students as per the schedule given in Academic Calendar. The external theory and Practical Examinations are conducted by the patron university as per schedule.

Special remedial classes, boost up classes, seminars, conferences, seminars, expert lectures, workshops etc. are continuously organized by the departments for the effective curriculum delivery.

The advanced learners are encouraged for further progression in career by providing them advance reading materials. During lockdown, due to Covid-19, since March 2020 the college administration made the online teaching-learning possible in spite of many hurdles. Students were able to integrate the specificity of the knowledge of their subject area.

# **Response:**

The college enables a strong and transparent mechanism of internal assessment of the students. The students are explained about the mechanism, rules and regulations of the internal assessment by the Head of the Department of the college during the orientation. The segregation of evaluation process of internal is done on the basis of student's performance in Mid Semester Tests, Assignments and Attendance in the class. Students are strictly evaluated keeping in view these parameters of evaluation that does not leave doubt among students. The internal assessment is uploaded on the portal of the Panjabi University, Patiala. Some of the steps taken are:

**Mid Semester Test:** Unit test are comprise of 50 of the total marks earmarked for Internal Evaluation. The examination branch, headed by the Registrar, plan and conduct the Mid Semester exams. The answer sheets are shown to the students and grievances are redressed, if any, by the faculty. Examinations are rescheduled for the students representing the college in sports and cultural events and also for those on medical leave.

**Attendance:** Utmost importance is given to class attendance which is necessary for Class internal evaluation. The students are informed well in advance about lecture shortage to get enough time to make up for the same. Internal assessment is displayed on the department notice board to ensure transparency. The students can approach the faculty for clarifications regarding the marking.

**Assignments:** 30 percent of the marks are allotted for Internal Evaluation is distributed and awarded on the basis of performance of the students on assignments, Seminars/ Group Discussions, Field Work.

#### **Mechanism of External Assessment**

- The College conducts university exams as per the guidelines of Punjabi University, Patiala under the college Principal as Chief controller examinations.
- The duties of superintendents are assigned by the university and the invigilators and other Supporting staff is deputed by the college.
- The college follows all guidelines and instructions strictly issued by the university time to time.

#### Mechanism for Internal/External Examination related Grievance:

The college has an effective mechanism to resolve grievances for internal and external examinations. The mechanism is transparent, time-bound and efficient. This mechanism includes the following tools to deal with Grievances like assessment, date sheet, internal examination, issuance of admit card, a wrong subject mentioned in the admit card, revised date sheet, incorrect/misprinted statements, 'Result Awaited', 'RLR', 'RLF', 'Absent' and correction of name and address in DMC, etc.

## **Procedure for lodging the complaint:**

Students can personally approach or put up a grievance in writing to the In-charge of the Grievance Committee.

#### **Procedure for solving the complaints**:

Committee reviews all the cases depending on the nature of issue and tries to resolve the issue as early as possible. Students are informed after taking necessary steps. The whole process remains transparent. The committee assures that the grievance has been properly solved in a stipulated time limit.

Each department ensures proper documentation of student progress to gauge the level of attainment. The college Career Guidance and Placement Cell endeavors to help the students to achieve the course outcomes by organizing workshops, extension lectures, special training sessions, brainstorming sessions, seminars and discussions with successful entrepreneurs and subject matter experts to expand their vision towards the relevance of their enrolled courses.

## **Response:**

Continuous evaluation is followed to analyse the attainment levels of POs and COs both for UG and PG programmes. It is ensured that each student is benefited from the course learned with respect to its stated outcome. Moreover, students securing university ranks, progressing into higher studies and prospective careers, qualifying state and national competitive examinations, having achievements in sports and

cultural activities have also been visible pointers used to determine the successful rendering of POs and COs.The success of any programme and its ensuing outcome can be assessed through comprehensive time bound assessment of the students. Some of the key indicators of measuring attainment are:

**Mid Semester Examinations:** Mid semester examinations, this includes about 50% of the syllabus of a respective semester, serve as an extremely effective tool to evaluate the performance of the students. These examinations prove to be an effective index for the students to measure their own performance keeping in view the final exams. Special tests are conducted for the students who missed the mid semester exams or fail to meet the minimum criteria for appearing in university final examination.

**Internal assessment:** Internal assessment is calculated as per the university norms based on their performance in mid semester examinations, regularity and participation in the classroom activities. The internal assessment constitutes a significant weightage in total marks in each subject.

**Final Semester Examinations:** The final evaluation of a student's academic performance is done through theory and practical examinations held every semester by Punjabi University, Patiala. The university appoints Centre superintendents, deputy and invigilators apart from flying squads to ensure fair examination.

**Internships/ Research work/ Projects:** Students of various streams of management, commerce, science and computer applications undergo internship/ project work and training to enhance their capacity for logical, critical and analytical thinking and problem-solving abilities.

**Practical/ Viva-Voce Examinations:** The practical examinations are conducted twice during the semester (one each before mid-semester and final examinations) to assess the students' level of understanding of the particular subject. During practical exams, the presence of an invigilator from outside the college ensures an impartial conduct of assessment of the students.

**Feedback Report:** The College collects feedback related to completion of the syllabus, level of attainment of knowledge and skills from the students and teachers. This helps in analyzing the attainment of PO. The Alumni Association also gathers information and maintains a database of where the alumni are placed as they shape out a position for themselves in the outside world. The ACRs filled by each faculty mentioning class results and the college achievers mentioned in the college prospectus are also the reflection of attainment of learning outcome.

**Student Progression and Placement:** Finally, the overall outcome of the course/ programme is evident from the successful progression of students in terms of their admission to higher education or their placements.

Along with seminar halls, various labs like 07 Computer Science Labs, Geography, Psychology, Physics, Chemistry, Fashion Technology and Life Science Labs like (Botany, Zoology, Horticulture and Agronomy) are also available for the enhancement of teaching and learning skills. There are specialized equipments for teaching & learning like 07 Multimedia projectors with Smart Board, projector & Interactive board. The whole campus is Wi-Fi enabled with internet leased line 30 Mbps bandwidth.

A Central library has been set up as a learning resource. To facilitate the students a Girls common rooms and a canteen has also been established. A placement cell is put in place to enable the students to avail opportunities for bright future. UGC Network Resource Centre & Teaching Aids Cells are also functional at the college campus. There are 06 Post Graduate Departments and 15 Under Graduate Departments for teaching. There are 32 CCTV cameras have been installed in the campus for effective surveillance. There is a branch of nationalized Punjab & Sind Bank with ATM for staff, students & others. A Vermicompositing unit, Botanical Garden and one rain water harvesting systems are built up in the college campus.

### **Response:**

Library plays very significant role in taking care of the needs of the students. The college authorities have taken special care in equipping the library with all types of facilities. The library has rich pool of reference books, national and international journals and e-sources, encyclopedia, biographies, newspapers and magazines etc. that are available in Punjabi, English and Hindi. The library is partially computerized and the material is arranged according to DDC 22nd latest edition. The Library has INFLIBNET service for e-journal and e-books. Wi-Fi facility is available in the library with 30 Mbps speed. Library has rich collection of books, magazines and e-resources. International Software eLib-Syspro 1.0. has also been installed in the library and has access to e-resources like (e-books and journals) provided by UGC-INFLIBNET, N-List Program through which it provides access to about 4000 ejournals and more than 80,000 e-books. Inter library loan facility is also provided to readers. Library subscribes 27 printed periodicals (Journals and Magazines) and 11 Newspapers. Open access system for both post graduates as well as under graduate students allows easy access of books. Laser printer cum scanner and photo copier are also available in library. Library also provides training / apprenticeship to the students of library and Information Science. This year also 03 students are undergoing training. Book bank facility is a unique feature of the institute where meritorious and economically weaker students are provided textbooks from the library. Every year a large collection of textbooks is added to the existing

book bank of the library. Library committee ensures that the outdated, old edition books or text books no longer prescribed by the university are removed from the stock and latest editions are added to the book bank for the benefit of the students. Punjabi University, Patiala has opened Distance Library Centre in this college for those students who are taking education from Correspondence Course, Punjabi University, Patiala and students are free to take books from this library.
